Residential Services seek to comprehensively meet the needs of the poor in a manner that dignifies and strengthens the individual, the family, and the community. Services include a 76-bed Men's Facility and a 37-bed Women's and Children's shelter. In addition to receiving shelter and clothing, residents may participate in the "Bridges to Freedom" discipleship and recovery program which includes life-skills training, vocational training, and numerous classes designed specifically to foster the journey from poverty to sustainability.

4b (Code:) (Expenses \$ 575,649 including grants of \$ 0) (Revenue \$ 0)

The Food Services team provides three meals a day to shelter residents and dinner meals for the community. Bagged meals are available 24/7 at the Men's Shelter. Good nutrition and learning success go hand in hand as evidenced by numerous studies indicating students who eat a healthy breakfast and/or lunch are more successful learners than those who do not. The Food Services department has a goal of providing men and women with healthy, well-balanced meals. Additionally, we strive to provide nutrition education to men and women so that they are able to make healthy food choices throughout their lives.

4c (Code:) (Expenses \$ 1,309,240 including grants of \$ 67,226) (Revenue \$ 1,613,970)

Education and Career services are comprised of several programs, including: Schenectady Bridges, Career Training Center, Employer Resource Network, Empower Health, Downtown Ambassadors, and Scholarships. Schenectady Bridges is a community-wide collaboration which provides training for those working with the less fortunate in order to make those efforts more effective. The Career Training Center offers shelter residents and community members job-readiness training. Employer Resource Network offers area employers an on-site success coach targeting the needs of the working poor in an effort to increase employee retention. Empower Health works to remove barriers to health by connecting the community to the health care resources. The Downtown Ambassador program assists in the ongoing revitalization of our city by helping to create a welcoming atmosphere for downtown visitors, providing entry level employment opportunities and teaching hospitality skills.

At the discretion of the Board or a committee thereof, a person with a real or apparent conflict of interest may be excused from all or any portion of discussion or deliberation with respect to the subject of the conflict. A member of the Board or of a committee thereof, who, having disclosed a conflict of interest nevertheless shall be counted in determining the existence of a quorum at any meeting where the subject of the conflict is discussed. The minutes of the meeting shall reflect the disclosure made, the vote thereon, and the abstention from participation in the voting by the individual making disclosure. The Board shall review any real or apparent conflicts prior to the occurrence of a transaction so disclosed is just, fair, and reasonable as to the organization and, if the Board so determines that it is just, fair, and reasonable, the trustees may authorize the transaction in the best interests of the organization.
